Katy Reid has a question about the LED stadium and the light strobes. Is the district assuring that we have an ambulance on site for students that have epilepsy or disorder that may have seizures during the light show? Please make it clear to the public that this may happen so people can take precautions. Javier Arroyo says that we all know that Dos Palos has an awesome cheer team, and cheer coach that everybody loves. There have been some meetings at the high school. The program starts at the youth and go to high school. There are approximately about 150 female athletes that attend every practice and attend tumbling class to try to be part of that program. There have been meetings that there are going to be changes to the program and who is running it. This has had a negative effect on the girls and there has been a lot of talks and rumors. It seems that it is not going in the right direction. I would like our current supporters and cheerleaders to be part of the decision making and to be heard. Several students spoke on the subject. One student decided to cheer for 9 years, and stated many people don't understand our program which include sideline cheers and competition. This gives those who cheer as sideline able to practice for competition. If the program is separated this will cause confusion for those that want to do sidelines and competition. Please do not change the success so far. A Sophomore of Dos Palos High School stated, Candice has done so much for this program. I've cheered for 10 years under her and have succeed. Candice has impacted my life and not just as a coach. She takes a lot of time to show us support. Changing this program would destroy the program we worked hard for. A parent stated her daughter has been coached under Candice, and her daughter has a cheer scholarship. They are true athletes and work very hard. No one else has a program like this. Leslie R. cheered for Dos Palos High School when Kelly Harmon coached. When I came in she was moved out and I was affected. Candice and David are the cheer for this town. If you take them out of this, football would go down too. Right now, what we have works, and it should stay that way. Pam M. has a cheer daughter since kindergarten. I have a new one coming into it as well. It inspires them to stay on track. They say that cheerleaders are not allowed to do other sports, that's not true. The main focus at the games is the cheerleaders. Robbing them from something they love can be detrimental for their mental health. They participate in the afterschool programs, etc. It's not right to take it away from them. These girls have a voice and you should hear them and their parents. If you make cheer an all inclusion, you need to make

the other sports all inclusion as well. Shealyn S. is a volunteer, parent, and coach, and has never felt that these girls are not good enough or get the attention and recognition they deserve. I am proud of these girls for speaking out. I've had parents reach out to me, and said they are scared to come and speak to you because their children would be retaliated against and would be held against their children. When it comes down to them it's about their mental health. They are keeping their grades up and getting scholarship. One signing on Tuesday for a full-ride scholarship. These girls won and they never received recognition, not a parade, not a dinner, not a certificate, nothing from the school. They need to be recognized and they deserve better. Amanda G. said there are so many rumors and I was asked to come and speak for cheer. I coached and this is my 13th year of coaching. Am I allowed to ask what exactly is going on? Mrs. Davis said at this time we can only listen, but we are not able to respond. Ms. Gonzalez wasn't sure if it was the spirit or lack of spirit. Is it the communication? Maybe we can figure a way to bring the spirit back. From what I've been told they are taking sideline and putting in a club. We just had to turn away 36 girls that didn't make the team. Hopefully we can get to a point of fixing it and do what is best for the kids. We are trying to build the program and not take away from it. A Dos Palos cheerleader has done cheer for the past 10 years. A lot of us are athletes as well. Putting sidelines in a different program would be very hard for us because we have other sports. We don't want you to take away something that we worked so hard to build.

#### 12.6 Contract for Services, Frontline Education (Formerly Forecast 5 Analytics)

Frontline Education is a comparable data tool that pulls statewide K-12 data to allow school districts to compare and benchmark against all California School Districts in the areas of Enrollment, Student Performance, Staffing, Salaries, Benefits, Accountability and Financials. Frontline Education loads district General Ledger data (historical actuals and current year budget) to allow client districts to build financial models and projections. **ORIGINAL Recommendation:** Recommend to approve customer agreement with Frontline Education for one calendar year.

#### 13.2 Resolution No. 23-24-14 Energy Services Efficiency Project and Contract Award to Syserco Energy Solutions - Melissa Kielpinski, Assistant Superintendent of Business Services

Dos Palos Oro Loma Joint Unified School District (District) selected Syserco Energy Solutions, Inc. (SES), a qualified Energy Services Company, to develop a District-wide, comprehensive energy services project. The process of developing the energy conservation measures (ECMs) for the District involved performing an Investment Grade Audit (IGA) at the majority of the District-owned facilities. The IGA established a historical energy and utility baseline and identified a comprehensive list of ECMs that would provide the best overall value to the District. The intent of this proposal is to summarize the project scope of work, cost, and savings for a comprehensive Energy Services project.

**Recommendation:** Recommend approval of Resolution No. 23-24-14 Energy Services Efficiency Project and Contract Award to Syserco Energy Solutions.
